DRI, MOST participates in the following topics of the 9th JFS Call for Research Proposals:

General area: Climate Change Adaptation & Local Resilience

Topics:

- Waste water treatment and reuse (industrial & municipal)
- Underwater and above-water biomass farms working with renewable energy
- Assessment and remediation of contaminated inorganic and organic soils

The Department of Research and Innovation (DRI) under the Ministry of Science and Technology does not offer funding to applicants from Myanmar . However, the DRI supports the involvement of Myanmar researchers in consortia-led proposals. For these researchers, it is necessary to ensure that they contribute their efforts in-kind to the projects. In such cases, other funding agencies involved in the call may cover additional costs like travel for Myanmar applicants, subject to their own national regulations. Myanmar applicants should consult the relevant national contact points to confirm their eligibility and understand how their participation can be financed before the consortium submits the full application.

Eligibility and funding modalities

Research proposals may be submitted by entities from Myanmar including:

- Research institutions
- Universities
- · Public or private research organizations
- Development agencies and SMEs

General Information:

Funding agencies for project partners may offer support for mobility and travel, accommodation, daily allowances, workshops and meetings, publications, consumables, and equipment, provided that Myanmar applicants cover their personnel costs in-kind. Please review the national regulations of the respective funding agencies.

Eligible cost categories

Personnel Costs:

These must be covered in-kind by the university or research institution and should be documented in a Letter of Commitment (LoC) attached to the application.

Other Expenses:

For costs such as travel, workshops, and consumables, please consult the national regulations of other partners who may offer support for these expenses.

Submission in addition to PT Outline submission

Before submission, it is advisable that each partner also reads the National Regulations of the other partners in the consortium, to understand and fit-in to the criteria specified in the partners' National Regulations.

In addition to submitting the proposal through the dedicated online tool (PT-OUTLINE), applicants must also send a signed PDF version of the PT-OUTLINE, including the institution's stamp, to the Myanmar National Focal Point
